MINUTES of the Parish Council meeting held on 4th April 2024

Part 1

24066. In attendance and declarations of interest: S Brown, Cllrs S Donoghue, R Hemingway (Chairman), M Patten, L Richardson, M Walton, B Wells and D Wint. S Look (Clerk). Member of the public. Divisional Cllr Arthur.

24067. Apologies: Cllrs R Arrand. **Declarations of interest:** Cllr Brown, Richardson and Wint declared an interest in item 24075i as committee members of the PFA.

24068. Minutes of the Parish Council meeting held on Thursday 4th April 2024 were proposed by Cllr Patten, seconded by Cllr Wint and unanimously agreed as a true and accurate record.

24069. Receive Divisional Councillor report:

Cllr Arthur has been in correspondence with a representative from the Springfield Close development as concerns are ongoing regarding the resubmission of changes to the original plans, the enforcement of trees, shrubs and bin stores and lack of timescales given by the planning enforcement team at NYC. **24070. Highways:**

- i. The Community Speedwatch has been organised for w/c 6th May 2024.
- ii. Cllr Heminway gave an update on the highways issues that were raised with NYC. The double yellow lines at the school entrance have still not been done. Cllr Hemingway to follow up.
- iii. VAS statistics to be presented to councillors on 4th May.
- iv. Streetlight no.26 at the end of School Lane on Main Street to be checked by Cllr Pattern to see if it has been fixed and report back to the clerk.
- v. Yorvik Homes have confirmed that they will extend the footpath outside the new development on Green Lane adjacent to allotments to join up with recently installed footpath. They are going to do it when the rest of the highway work is done which they are still waiting permission to do. The Highways inspector needs to agree the connection position. Councillors also raised an issue with a patch of dirt track where cars are parking – agreed to monitor in relation to the original plans.
